- 2. The said committees will exercise such powers and discharge such duties as conferred on such committees under the Juvenile Justice (Care and Protection of Children) Act, 2015 and the Juvenile Justice (Care &Protection of Children) Model Rules, 2016.
- 3. The committee shall function as a Bench and shall have the powers conferred by the Code of Criminal Procedure, 1973 (2 of 1974) on a Metropolitan Magistrate or, as the case may be, a Judicial Magistrate of First Class.
- 4. The Committee shall sit on all working days for a minimum of six hours commensurate with the working hours of a magistrate prescribed in rule 16(7) of the Juvenile Justice (Care & Protection of Children) Model Rules -2016.
- 5. The Committee shall meet on at least 20 (Twenty days) in a month and shall observe such rules and procedures with regard to the transaction of business at its meetings, as may be prescribed in section 28(1) of the Juvenile Justice (Care & Protection of Children) Act, 2015.

- 6. The Committee shall also discharge such additional functions and responsibilities as prescribed in Rule -17 of the Juvenile Justice (Care & Protection of Children) Model Rules -2016.
- 7. The tenure of the Chairperson and Members of the Child Welfare Committee shall not be more than for a period of 3(three) years from the date of notification of their appointment. They shall join their duties immediately not later than 6th February, 2021.
- 8. The appointment of chairperson and members of the Child Welfare Committee may be terminated after making an inquiry by the State Government, if chairperson/Member becomes ineligible under Sub section 7 of the Section 27 of the Juvenile Justice (Care & Protection of Children) Act, 2015.

The Notification will come into force with immediate effect.
