The success or otherwise of the scheme mainly depends on them. This applies equally to the Anganwadi Services scheme which is largely implemented at the field level by the CDPOs, Supervisors, Anganwadi Workers and Anganwadi Helpers. The aforesaid functionaries are the backbone of the scheme and without their in position and participation, the success of the scheme cannot be visualised.
