ELIGIBILITY CRITERIA AND TERMS & CONDITIONS OF SERVICE FOR CHAIRPERSON AND MEMBER OF CHILD WELFARE COMMITTEE

- 1) **Citizenship** - The applicant should be an Indian citizen.
- 2) **Eligibility** - No person shall be appointed as a member of the Committee unless he has a degree in child psychology or psychiatry or law or social work or sociology or human health or education or human development or special education for differently abled children and has been actively involved in health, education or welfare activities pertaining to children for seven years

OR

is a practicing professional with a degree in child psychology or psychiatry or law or social work or sociology or human health or education or human development or special education for differently abled children

- 3) **Age:** Above of 35 years on the date of publication of this notice.
- 4) **Terms & conditions**
 - i) **Number of Chairperson & Members:** In each district 1(one) Chairperson and 4(four) Members. Out of 4 (four) members at least one shall be a women and one shall be an expert on the matters concerning children.
 - ii) **Honorarium:** Honorarium shall be paid for each full time meeting as per Govt. norms, changeable as per Govt. rules and subject to sanction.
 - iii) The term of appointment of Members will not more than 3(three) years. A member of the Committee shall be eligible for appointment of maximum of two terms, which shall not be continuous.

5) No person shall be eligible for selection as a member of the Committee, if he—

- (i) has any past record of violation of human rights or child rights,
- (ii) has been convicted of an offence involving moral turpitude, and such conviction has not been reversed or has not been granted full pardon in respect of such offence,
- (iii) has been removed or dismissed from service of the Government of India or State Government or an undertaking or corporation owned or controlled by the Government of India or State Government,
- (iv) has ever indulged in child abuse or employment of child labour or immoral act or any other violation of human rights or immoral acts, or
- (v) is part of management of a child care institution in a District or be associated with any Child Care Institution, directly or indirectly, during his/her term as a member of the Committee or have any other conflict of interest.
- (vi) be holding such full-time occupation that may not allow the person to give necessary time and attention to the work of the Committee as per the Act and Rules
- (vii) hold any office in any political party during his tenure.
- (viii) be insolvent.
