In exercise of the powers conferred under Section-27 of the Juvenile Justice (Care & Protection of Children) Act, 2015 (as amended) and Rule 15 of the Juvenile Justice (Care & Protection of Children) Model Rules, 2016 and as per the recommendations of the selection committee constituted vide Notification No.F.87(1-306)-CW/DSWE/2017/2103(15) dated 21-08-2020 of Education (Social Welfare & Social Education) Department, Government of Tripura, the **Child Welfare Committee** in respect of **Dhalai District, North Tripura District, Unakoti District and Gomati District of Tripura** is hereby re-constituted as below :



2. The said Child Welfare Committees will exercise such powers and discharge such duties as conferred on such committees under the Juvenile Justice (Care and Protection of Children) Act, 2015 (as amended) and the Juvenile Justice (Care & Protection of Children) Model Rules, 2016.
3. The Child Welfare Committees shall function as a Bench and shall have the powers conferred by the Code of Criminal Procedure, 1973 (2 of 1974) on a Metropolitan Magistrate or, as the case may be, a Judicial Magistrate of First Class.
4. The Child Welfare Committees shall sit on all working days for a minimum of six hours commensurate with the working hours of a magistrate court, as prescribed in rule 16(7) of the Juvenile Justice (Care & Protection of Children) Model Rules, 2016.


5. The Child Welfare Committees shall meet on at least 20 (Twenty days) in a month and shall observe such rules and procedures with regard to the transaction of business at its meetings, as may be prescribed in section 28(1) of the Juvenile Justice (Care & Protection of Children) Act, 2015 (as amended).
6. The Child Welfare Committees will exercise the power as per provision mentioned under Section 28, 29, 30 of the Juvenile Justice (Care & Protection of Children) Act, 2015 (as amended) and as per Rule 15, 16, 17 of the Juvenile Justice (Care & Protection of Children) Model Rules, 2016.
7. The tenure of the Chairperson and Members of the Child Welfare Committees shall not be more than for a period of 3(three) years from the date of appointment w.e.f. 05/09/2022. They shall assume the charge on 05/09/2022. Tenure shall be counted from 05/09/2022 irrespective of date of joining after 05/09/2022.
8. The appointment of chairperson and members of the Child Welfare Committee may be terminated after making an inquiry by the State Government, if Chairperson/Member becomes ineligible under Sub section 7 of the Section 27 of the Juvenile Justice (Care & Protection of Children) Act, 2015 (as amended).
9. It shall come into force on the date of its publication in Tripura Gazette.
10. The notification No.F.87 (1-613)/CW/DSWE/2022/11010 (58) dated 11/03/2022 issued by the Education (Social Welfare & Social Education) Department, Government of Tripura stand suspended on 04/09/2022.
