2. The Social Worker Member of the Juvenile Justice Board shall exercise such powers and discharge such duties as conferred on them under the Juvenile Justice (Care and Protection of Children) Act, 2015 and the Juvenile Justice (Care & Protection of Children) Model Rules, 2016.

3. The term of the Social Worker Members of the Board shall not be more than for a period of three years from the date of notification of their appointment. They shall join their duties immediately not later than **6th February, 2021**.



4. The appointment of Social Worker Members of the Juvenile Justice Board may be terminated after making an inquiry by the State Government, if Social Worker Members becomes ineligible under Sub section 7 of the Section 4 of the Juvenile Justice (Care & Protection of Children) Act, 2015.

The Notification will come into force with immediate effect.
