The Social Worker Members of the Juvenile Justice Boards shall exercise such powers and discharge such duties as conferred on them under the Juvenile Justice (Care and Protection of Children) Act, 2015 (as amended) and the Juvenile Justice (Care & Protection of Children) Model Rules, 2016. The Social Worker Members of the Juvenile Justice Boards will exercise the power as per provision mentioned under Section 8, 9 of the Juvenile Justice (Care and Protection of Children) Act, 2015 (as amended) and as per Rule-7 of the Juvenile Justice (Care & Protection of Children) Model Rules, 2016.
- 3. The term of the Social Worker Members of the Juvenile Justice Boards shall not be more than for a period of 3(three) years from the date of appointment w.e,f. 05/09/2022. They shall assume the charge on 05/09/2022. Tenure shall be counted from 05/09/2022 irrespective of date of joining after 05/09/2022.
- 4. The appointment of Social Worker Members of the Juvenile Justice Boards may be terminated after making an inquiry by the State Government, if Social Worker Members becomes ineligible under Sub section 7 of the Section 4 of the Juvenile Justice (Care & Protection of Children) Act, 2015 (as amended).
- 5. It shall come into force on the date of its publication in Tripura Gazette.
- 6. The notification No.F.87 (1-401)/CW/DSWE/2020/9912 (18) dated 12/01/2022 issued by the Education (Social Welfare & Social Education) Department, Government of Tripura stand suspended on 04/09/2022.
