3.3.1 Date of Interactions: Date of interactions has been scheduled as follows-







3.4 Criteria for assessment of applicants during interaction:

3.4.1 Selection would be done purely on merit basis i.e marks obtained during interaction. The Committee decided that assessment of suitability of candidates shall be done on the following 05 (five) parameters.




- i. Personality (Max. 10 Marks)
- ii. Qualification (Max. 10 Marks)
- iii. Experience/ Activity (Max. 10 Marks)
- iv. Aptitude/ Motivation (Max. 10 Marks)
- v. Personal accomplishment/ achievement in the concerned area. (Max. 10 Marks)

The Chairperson and the other members of the Committee shall have 50(fifty) marks each. The Candidate will be ranked on the basis of the average of the cumulative marks obtained by a candidate. District wise empanelment shall be done as per the merit list and their preference respectively.

3.4.2 The Committee asked for the presentation of performance appraisal report of incumbent Chairperson and Member of a Child Welfare Committee and Social Worker Member of a Juvenile Justice Board who applied for the position under this engagement drive. Also asked the Member Secretary to obtain the same from the concerned District Magistrate & Collector and District Judge for the Chairperson & Member in CWCs and Social Worker Member in JJBs respectively under Rule.88(6) of the Juvenile Justice (Care & Protection of Children) Model Rule,2016.
