**Last Date for receiving applications till 06/05/2025**

Applications are invited from the eligible candidates with requisite qualifications, in the prescribed application form, for serving as "Chairpersons & Members of the Child Welfare Committees" and "Social Worker Members of the Juvenile Justice Boards" for four and three districts of Tripura respectively under Juvenile Justice (Care & Protection of Children) Act, 2015 and its Amendment Act, 2021 and the Juvenile Justice (Care and Protection of Children) Model Rules, 2016 and its Amendment Rules, 2022.

The application with bio-data along with (self-attested) copies of the credentials should be submitted online at <http://164.100.127.84/test/app/swse> from 06.05.2025. The last date for submission of application is 26/05/2025 until 11:59 PM. The link is also available in the Departmental website i.e <https://socialwelfare.tripura.gov.in/>

The applicant should use only one application form for a position, even if he/she chooses to apply for more than one district in a CWC or JJB. If applicant wants to apply for more than one position he/she shall submit different form. The applicant must be a resident of Tripura State. Only applications submitted through online within due date will be accepted.

The applicants are requested to note that these appointments are not salary-based employments. These are purely tenure-based appointments to deal with the cases of the "Children in Need of Care & Protection" and 'Children in Conflict with Law and they will be paid sitting allowance / honorarium as may be fixed by the State Government. The maximum term period is 3 years.

Only those shortlisted applications, which fulfil the basic eligibility/criteria and required qualifications, will be considered to place before the Selection Committee. The shortlisted candidates may be called for a personal interaction/interview with the Selection Committee for final selection at a venue which will be communicated later.

For any further information, please contact at the Office of District Inspector of Social Education of respective district or at the Directorate of Social Welfare & Social Education, Abhoynagar, Agartala during office hours excluding public holidays.

**Note:**

1. The Member Secretary, Selection Committee (Director, Social Welfare & Social Education, Tripura has all the rights to cancel or modify the notification at any time before finalization of the selection.
2. Wherever the information furnished by the applicant is sought to be supported by a proof of document which shall be self-attested and if the applicant fails to submit the proof of document along with the application or if the such document is not self-attested, such information will be construed as it has no value, and the Screening Committee will have the authority to take a decision in such cases, based on the information available before the Committee, which shall be final. All documents shall invariably be attested by the individual.

**Eligibility Criteria and Criteria for Ineligibility for the position of Member and Chairperson of CWC:-**

Eligibility Criteria	<b><u>EDUCATION QUALIFICATIONS &amp; EXPERIENCE:</u></b>  As per Sub Section (4) of Section 27 of Juvenile Justice (Care & protection of Children) Amendment Act, 2015:  (i) Shall have a Degree in child psychology or psychiatry or law or social work or sociology or human health or education or human development or medicine or special education for differently abled children from any recognized University.  <b>AND</b>  Has been actively involved in health, education or welfare activities pertaining to children for at least <b><u>seven Years</u></b> .  <b>OR</b>  (ii) Should be a <b><u>practicing professional</u></b> with a degree in Child psychology or Psychiatry or Law or Social Work or Sociology or Human health or education or human development or special education for differently abled children.
Age Specification	Shall be above the age of 35 years and not more than 65 years on the date of



	notification.
Criteria for Disqualification/ Ineligibility:	<p>A. A person to be selected as a Chair person or Member of the Committee-</p> <ul style="list-style-type: none"> <li>i) should not have any past record of violation of human rights or child rights,</li> <li>ii) should not have been convicted of an offence involving moral turpitude and if such conviction has not been reversed or has not been granted full pardon in respect of such offence;</li> <li>iii) should not have been removed or dismissed from service of the Central Government or State Government or an undertaking or corporation owned or controlled by the Central Government or State Government,</li> <li>iv) should not have ever indulged in child abuse or employment of child labour or any other violation of human rights or immoral act;</li> <li>v) should not be part of management of a child care institution in a district;</li> <li>vi) should not be holding such full-time occupation that may not allow the person to give necessary time and attention to the work of the Board or Committee as per the Act and Rules.</li> <li>vi) should not hold any office in any political party during his/her tenure.</li> <li>vii) should not be insolvent.</li> </ul> <p>B. A member of the Committee shall be eligible for appointment of <b>maximum of two terms</b>, which shall not be continuous. Provided there is no bar for a member of a CWC to apply for the position of Chairperson of the CWC.</p> <p>C. The person applying for the post of the Chairperson or member of the Committee shall submit an undertaking in the application form (as prescribed in Form 49), certifying that the applicant is not barred by any of the conditions laid down in subsection 4A of section 27 of the Act.</p> <p>D. A person associated with an organization receiving foreign contribution shall not be eligible to be a Chairperson or member of the Committee.</p> <p>E. Any person working in the implementation of the Act in any Non-Government Organisation or any organisation, performing such functions which may cause conflict of interest in discharge of their duties as the Chairperson or member of the Committee shall not be eligible for appointment as the Chairperson and member of the Committee.</p> <p>Explanation: For the removal of doubt, it is hereby clarified that, this may include but is not limited to any of the following situations within the territorial jurisdiction of the Committee:</p> <ul style="list-style-type: none"> <li>(a) any family member is a member of any non-governmental organisation,</li> <li>(b) close relation is a member of any non-governmental organisation;</li> </ul>

**Eligibility Criteria and Criteria for Ineligibility for JJB Social worker members:-**

Eligibility Criteria	<p>Shall be a practicing professional with a degree in the field of child psychology or psychiatry or sociology or law;</p> <p style="text-align: center;"><b>OR</b></p> <p>Has been actively involved in health, education, or welfare activities pertaining to children for <b><u>at least seven year.</u></b></p>
Age Specification	Shall not be less than 35 years of age and shall not more than 65 years of age as on the date of notification.
Criteria for Disqualification / Ineligibility:	<p>A) A person to be selected as a Social Worker Member of the Board-</p> <p>i) should not have any past record of violation of human rights or child rights;</p> <p>ii) should not have been convicted of an offence involving moral turpitude and if such conviction has not been reversed or has not been granted full pardon in respect of such offence;</p> <p>iii) should not have been removed or dismissed from service of the Central Government or State Government or an undertaking or corporation owned or controlled by the Central Government or State Government;</p> <p>iv) should not have ever indulged in child abuse or employment of child labour or any other violation of human rights or immoral act;</p> <p>v) should not be holding such full-time occupation that may not allow the person to give necessary time and attention to the work of the Board or Committee as per the Act and Rules.</p> <p>vi) should not hold any office in any political party during his/her tenure.</p> <p>vii) should not be insolvent.</p> <p>viii) should not be associated with any Child care Institutions, directly or indirectly, during his tenure as a member of the Board or have any other conflict of interest;</p> <p>B) A social worker member of the Board shall be eligible for appointment of</p>
