1. These rules may be called the Tripura Blind & Handicapped Pension (3<sup>rd</sup> amendment) rules 2008.
2. The Tripura Blind & Handicapped Pension Rules is renamed as the "Tripura Blind & Handicapped Assistance Scheme".
3. The existing beneficiaries who are on receipt of benefit under this scheme shall continue to do so. On the death of such BHP beneficiaries, the replacement shall be from amongst the disabled persons with an eligible level of disability i.e. above 60%.

This will be effective from 1st November 2008.





**NOTIFICATION**

The Governor has been pleased to revise the existing guidelines of the Pension scheme for the 100% Blind Persons with the following changes.

1. "The pension scheme for the 100% Blind Persons" shall be renamed as " Allowance for 100% Blind"
2. The age group is reduced from "18 years and above" to "10 years and above" to cover all eligible blind persons under BPL category.
3. New applicants can apply to the respective CDPOs duly backed by supporting documents including a Medical Certificate as per prescribed application form.
4. The existing beneficiaries who are on receipt of benefit under the scheme shall continue to do so.
5. The rate of allowance for the 100% Blind would remain as per the existing rate (Rs. 1000/- per head per month).

This will be effective from 1<sup>st</sup> November, 2008.
