
NOTIFICATION

The Governor has been pleased to revise the existing guidelines of the Pension to 80% and above physically challenged persons with the following changes.

1. The pension scheme for **the "80% and above Physically Challenged Persons"** shall be renamed as **"Disability Allowance"**.
2. The age group is reduced from **"18 years and above"** to **"10 years and above"**.
3. For assistance under this scheme, eligibility criteria has been reduced from 80% to 60% and above disability and will be applicable for all categories of disabled (physical, mental, or multiple) persons under BPL category.
4. New applicants can apply to the respective CDPOs duly backed by supporting documents including a Medical Certificate as per prescribed application form.
5. The existing beneficiaries who are on receipt of benefit under the scheme shall continue to do so.
6. The Disability Allowance would remain as per the existing rate (Rs. 300/- per head per month).

This will be effective from 1st November, 2008.
