NOTIFICATION

The Governor, Tripura is pleased to hereby introduce Pension Schemes for Folk Artistes/Carpenters/Pottery Workers/ Blacksmiths/ Schedules Castes traditionally connected with sanitation work (Harijan), with immediate effect. The details of the scheme are as follows:-

**1. Name of the Scheme:** - Pension Scheme for Folk Artistes/Carpenters/Pottery Workers/ Blacksmiths/ Schedules Castes traditionally connected with sanitation work (Harijan).

**2. Eligibility Criteria for Beneficiaries :-**

- i) The applicant must be a resident of Tripura,
- ii) The applicant must be 55 years or above of age,
- iii) Annual income of the person should not exceed Rs. One Lakh per annum , and
- iv) No member of the family of the person should be in Government service. ('Family' for this purpose would mean father, mother, son (s) or unmarried daughter(s), as the case may be).

**3. Rate of Pension :-** Rs. 700/- per month per beneficiary.

**4. Method of selection of Beneficiaries :-**

Applications would be invited in the prescribed form (at Annexure to this notification) from the eligible persons by giving wide publicity through print and electronic media. Application should be submitted to the office of the Child Development Project Officer (CDPO) of the concerned area, along with requisite documents mentioned in the above form. The CDPO would refer it to concerned Panchayat Samity/BAC/ULB for recommendation. Once recommended it would be sent to the SW&SE Directorate for sanction.

**5. Sanctioning Authority :-**

The SW&SE Deptt. will sanction the pension to the eligible persons.

**6. Evaluation and Monitoring :-**

The Department would monitor the progress of payment of selected Beneficiaries in each month and submit a report to the govt. in each month.

**7. Others :-**

The Govt. may make any change in the scheme as and when required.

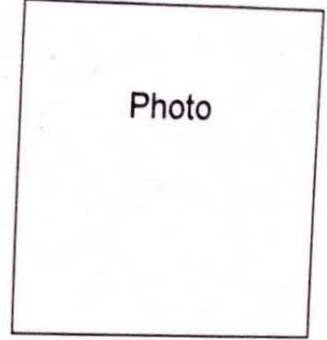
