- 2. The Social Worker Members of the Juvenile Justice Boards shall exercise such powers and perform such function as conferred on them under the Juvenile Justice (Care and Protection of Children) Act, 2015 (as amended) and the Juvenile Justice (Care & Protection of Children) Model Rules, 2016.
- 3. The above appointed Social Worker Members of the Juvenile Justice Boards shall assume the charge immediately. The term of the Chairperson and Members of the Child Welfare Committees shall not be more than for a period of 3(three) years w.e.f. the date of issuance of this Notification.

- 4. The appointment of Social Worker Members of the Juvenile Justice Boards may be terminated after making an inquiry by the State Government, if Social Worker Members becomes ineligible under Sub section-7 of the Section-4 of the Juvenile Justice (Care & Protection of Children) Act, 2015 (as amended).
- 5. The Notification The Notification No.F.87 (1-401)/CW/DSWE/2020-Part(1) dated 06/02/2024 issued by the Education (Social Welfare & Social Education) Department, Government of Tripura in connection with the additional charges of the existing JJBs stands cancelled.
- 6. The Social Worker Members of the Juvenile Justice Boards hereby appointed shall submit their joining report to their respective office of the District Child Protection Officer, (DISE) addressed to the Director, Social Welfare & Social Education, through the O/o District Child Protection Officer, (DISE).
- 7. This notification shall have immediate effect.
