## MEMO

It is decided by the Department of Social Welfare & Social Education to allow another opportunity for submission of documents for those who had remained absent or were unable to submit the required documents etc during the re-verification process held from 15th Dec'2020 to 25th January'2021.

The terms & conditions shall remain same as reference vide Memo Ref No. 3(66) /DSWE/PEN.CELL/2011/(Vol-IV) dated 14-12-2020.

The scheduled timeline for submission of application to avail the above opportunity is from **28**<sup>th</sup> **June 2021 to 05**<sup>th</sup> **July'2021** and such willing beneficiaries shall be allowed to submit a fresh application to the CDPOs with all requisite supporting documents.

After receiving the proposals from the beneficiaries, the CDPOs shall make a careful scrutiny regarding their eligibility as claimed and confirm whether the claims are only from those in the FDLs(Final Deletion List) and USL (Unsettled List) which were finalized earlier. After examination, the data will be prepared as per the attached format to submit to the DISEs of the respective District within 8th July'2021.

The DISEs are requested to look into the matter so that on **12thJuly' 2021** the final list and other documents are received by this Directorate to restore the pensions of acceptable applicants after scrutiny and for further regularisation the beneficiaries from July' 2021 onwards.
