NOTIFICATION

The Governor is pleased to introduce a new scheme for providing social pension to the unorganised workers like Motor Shramik Workers, Handloom Workers, Laundry Workers and Barber Workers. The details of the scheme are as follows:

1) **Name of the Scheme:**

Scheme for providing pensions to the BPL unorganized workers - Barber Workers, Laundry Workers, Motor Sharamiks Workers and Handloom Workers.

2) **Targeted Beneficiaries:**

4 (four) categories of unorganized workers, namely Motor Shramik Worker, Laundry Worker, Barber Worker and Handloom Worker shall be eligible for getting the pension with the following conditions:

- (i) He/she shall be 55 years and above age and belonged to BPL category.
- (ii) He/she shall have the 10 years experience in profession.
- (iii) He/she shall have to furnish an experience certificate may be issued by the concerned Gram Panchayat/Village Committee/ Nagar Panchayat/AMC.
- (iv) In case of Motor Shramik Worker in addition to the 10 years' experience, they should have the driving license

If any person is covered by any other Social Security Scheme of the State Government then he/she shall not be eligible for getting pension in the scheme.

3) **Rate of Pension:**

Rs.400/- per month per beneficiary.

4) **Projected number of beneficiaries to be covered under the scheme:**

It would be decided after inviting applications giving wide publicity through local newspapers and other media.

5) **Proposed date for implementing the scheme:**

1st November 2012.

6) **Method of selection of beneficiaries:**

The application would be invited as per the format from the candidates belonging to BPL giving wide publicity through print media and electronic media for submitting it to the Gram Panchayat/Village Committee/Nagar Panchayat/AMC. On getting the applications the concerned Gram Panchayat/Village Committee/Nagar Panchayat/AMC would send it to the Labour Department with the recommendation. The Labour Department may consider these cases and recommend it to the CDPO for sanction.

7) **Sanctioning Authority:**

The CDPOs will sanction the pension in consultation with the Labour Department and with prior approval of the Government in the Department of Social Welfare & Social Education.

8. **Evaluation & monitoring:**

The Department would monitor the progress of payment of selected beneficiaries in each month and submit a report to the Government in each month.

9. **Others:**

The Government may make any change in the scheme as and when required.
