

Selection Committee

(Constituted in terms of Rule.87 of the Juvenile Justice (Care & Protection of Children) Model Rules,2016 vide Notification 87(1-401)-CW/DSWE/2020-Part(1) Dated 04.01.2024)

The Selection committee has held a sitting today in presence of all the seven members of the Committee and the records of the proceedings are as follows.

1. As per resolution dated 22/01/2024 of the Selection Committee 50(fifty) marks was allotted to each of the following member of the Committee including the Chairperson under the following heads.

Personality	Qualification	Experience/Activity	Aptitude/ Motivation	Personal Accomplishment/ Achievement in the concerned area.
10 marks	10 marks	10 marks	10 marks	10 marks

2. Each of the members including the Chairperson present during the interaction has awarded marks to the Candidates as per his/her own and independent assessment of the candidate.
3. Total marks obtained by a candidate have been divided by the number of members of the Selection Committee available during interaction to determine the merit position of the candidate.

Say for example, 04 member of the Selection Committee were present during interaction. Out of 50 marks, Member A has given 25 marks, Member B has given 30 marks, Member C has given 35 marks, and Member D has given 40 marks to a Candidate. Thus, the candidate has scored $25+30+35+40 = 120$ marks which has been divided by 4 to determine the merit position of the candidate. Resultantly, the candidate scores $120 \div 4 = 30$.

4. Separate Panels as per law have been prepared for the vacancies in the posts of Chairperson, CWC and Members, CWC and also for the vacancies in the post of Social Worker Member in JJB.



Resolved accordingly.


