Notice Inviting Tender

Sealed tender/quotation is hereby invited from Co-operative Society/SHG (only under Sadar Sub-Division, Agartala) for supply of Masur Dal best quality weekly approximately 4500 Kg to the office of the CDPO Agartala-2 ICDS Project Abhoynagar, Agartala, Tripura West, for the purpose of SNP of the Agartala-2 ICDS Project for the month of August and September, 2022 on the following terms and conditions (it may be extended another two or three months if supply is satisfactory).

Terms & Conditions:

1. The tenderer/quotationer shall have valid trade license.
2. The tenderer/quotationer must be registered with co-operative Societies (in case of LAMPS/ PACS & Other Co-operative Societies) /DRDA (Incase of SHG's).
3. The supplier shall supply the Masur Dal within 3 days from the date of receipt of supply order. Except Co-Operative societies / SHG/ Rs. 50,000/- D Call should be submitted during dropping of rate of Masur Dal.
4. The tenderer/quotationer shall submit their rates in the following format to the office of the CDPO, Agartala-2 ICDS Project.



5. The tenderer/quotationer will deliver the Masur Dal in the SNP Go-down of the CDPO office safely.
6. Masur Dal will be 30 Kgs gunny bag in net weight stretch with company seal bag (Masur Dal weight must be 30kg)
7. Tenderer/quotationer will submit a delivery challan in course of supply of Dal and thereafter Bill in Triplicate along with a copy of delivery Challan.
8. Payment will be made as and when Fund is available. 2% income tax and GST will be deducted (if applicable) from the bill as per Govt. norms.

How to submit tender

1. The tenderer/quotationer will submit the copy of valid ITC along with the tender.
2. Tenderer/quotationer shall submit their rate in the following format (Format-I) and other documents in a sealed cover addressed to the CDPO Agartala-2 ICDS Project, Abhoynagar, West Tripura. The Envelope should be superscripting "Tender for best quality Masur Dal" and the name and Address of the supplier. They will submit a separate envelope superscripting "SAMPLE OF MASUR DAL" Tender/quotationer without Earnest Money Deposit and sample will be automatically rejected (other than Co-Operative society).
3. The CDPO, Agartala-2 ICDS Project has the right to reserves or cancels any or all the tender at any time without assigning any reason. The decision of the CDPO, Agartala-2 ICDS Project, will be treated as final. The tenderer/ quotationer shall submit their rate(s) in plain A4 paper on the following format.
