



ELIGIBILITY CRITERIA AND TERMS & CONDITIONS OF SERVICE FOR
WOMEN SOCIAL WORKER MEMBER
IN JUVENILE JUSTICE BOARD OF NORTH TRIPURA DISTRICT

- 1) The applicant should be an Indian citizen.
- 2) At least 7(seven) years experience of working with children in the field of education, health, or welfare activities, or should be a practicing professional with a degree in child psychology or psychiatry or sociology or in the field of law.
- 3) Age: Not less than 35(thirty five) years on the date of publication of this notice.
- 4) Terms & conditions
 - i) Number of Member: 1 (one) women Member for Juvenile Justice Board of North Tripura District.
 - ii) Honorarium: Honorarium shall be paid for each full time meeting as per Govt. norms, changeable as per Govt. rules, /and subject to sanction.
 - iii) The term of appointment social worker Member will not more than 3(three) years. A member of the Board shall be eligible for appointment of maximum of two terms, which shall not be continuous.
 - iv) A member should not be selected if he/she is holding such full-time occupation that may not allow the person to give necessary time and attention to the work of the Board as per the Act and Rules. A member should not be selected if he/she be associated with any Child Care Institution, directly or indirectly, during his/her term as a member of the Board or have any other conflict of interest. A member should not be selected if he/she hold any office in any political party during his/her tenure. A member should not be selected if he/she be insolvent.
- 5) Any applicant shall not be eligible for selection as a social worker member of the Juvenile Justice Board, if she –
 - a) Has any past record of violation of human rights or child rights;
 - b) Has been convicted of an offence involving moral turpitude, and such conviction has not been reversed or has not been granted full pardon in respect of such offence;
 - c) Has been removed or dismissed from service of the Central Government or a State Government or an undertaking or corporation owned or controlled by the Central Government or a State Government;
 - d) Has ever indulged in child abuse or employment of child labour or any other violation of human rights or immoral act.
